

# WHAT IS A DNA TEST?

A DNA test is a laboratory-conducted test designed to determine the kinship of two individuals. Most common uses include determining whether or not a male is the biological father of a specified child, but may also be used to determine a mother's relation to a child, other kinship relationships, ancestral enrollment, and individual tests for records purposes. The test requires consent from all parties involved and consent of the parent/guardian if a tested individual is under 18 years of age.

#### HOW DOES THE TEST WORK?

DNA samples are taken from the tested individuals, in a Paternity Test, these may include the mother, the alleged father(s), and the child. These samples are then sent to a laboratory that will search for specific DNA markers. These markers will differ greatly from person to person unless the subjects are related. The technical name for this process is (STR) or Short Tandem Repeat.

## HOW ARE THE SAMPLES TAKEN?

Samples are collected using a non-invasive and painless mouth swab. This swab, once rubbed inside the cheek, collects cells that contain the DNA sample. Depending on the type of test needed, the parties being sampled don't need to be present at the same time, but need to provide consent in order to complete the test.

# WHAT TYPE OF TESTS ARE THERE?

There are two basic types of DNA tests performed. The first is a Chain of Custody test, these tests are performed in witness of a third party with specific chain of custody documents completed. This first type can be used in court and government-related cases such as child support and custody court cases, immigration, adoption, or to change the name on a child's birth certificate.

The second type of paternity test is known as curiosity test because there is no chain of custody needed for these tests and cannot be used in court. Curiosity tests are for personal use only. Kits may be purchased online or at specialty retailers, but they run the risk of contamination and, therefore, the reliability of the results is drastically reduced. It is highly recommended that any DNA test be conducted by a trained and certified DNA collection professional to ensure the security and reliability of the results and may be used in the future legal conflicts such as estate disputes.

# **KEY POINTS:**

- The mother does not need to be present to perform the test; however, it provides a more accurate reference marker and may be required in some court or government cases
- You do not need a court order to get a Chain of Custody test performed.
- You do not need a doctor's prescription to get a paternity test performed.
- A child of any age can be tested with the appropriate consent
- If the alleged father is deceased at the time of testing, the father's parents can give the samples.
- We can also test for kinship, adoption, individual (records purposes) and tribal enrollment.
